Pursuant to Florida Statutes, a monthly report is required by all manufacturers, distributors, importers, brokers, and sales agents of alcoholic beverages (561.55), all distributing agents and wholesale distributors of cigarettes (210.09), and wholesale distributors of tobacco products (210.55), showing all product activity and remitting payment of any and all excise taxes due for the previous month. *All reports are to be filed with the appropriate District Auditing Office (listed below) on or before the tenth day of the month following the month for which the report is made.*
