TO: COMMISSIONER OF REVENUE, Georgia Department of Revenue KNOW ALL PERSONS BY THESE PRESENTS:  That we, the principal and the surety company as surety, hereby acknowledge ourselves jointly and severally held and firmly bound unto the State of Georgia for any liabilities due for motor carrier fuel taxes and upon the conditions hereinafter set forth in the full sum of the penal sum named herein for the payment of which shall well and truly to be made we bind ourselves, our administrators, executors, successors and assign jointly and severally, firmly by these presents.  The condition of the foregoing obligation is such that the above named principal has been duly registered as a Motor Carrier operator of vehicles subject to the provisions of Title 48, Chap. 9, Article 2 of Georgia Law.  Now therefore, should the said principal well and truly comply with all the requirements and laws as set forth in Title 48, Chap. 9, Article 2, of Georgia Law as amended, and pay all taxes therein required, and penalties assessed thereunder, then this obligation to be void; otherwise, of full force and effect.
