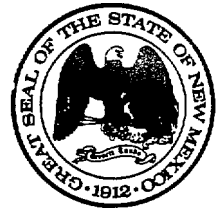

II. WHEREAS, THE ABOVE BOUNDEN _____ BEING DULY REGISTERED AND LICENSED AS
DEFINED IN ARTICLE 16, CHAPTER 7, LAWS OF 1978, (AS AMENDED, IN THE STATE OF NEW MEXICO.

III. WHEREAS, THE ABOVE BOUNDEN _____ BEING DULY REGISTERED BY THE MOTOR
TRANSPORTATION DIVISION FOR FEES AND TAXES AS DEFINED IN CHAPTER 7, LAWS OF 1978 (ARTICLE 16) AND CHAPTER 66,
LAWS OF 1978, (ARTICLE 6) IN THE STATE OF NEW MEXICO.

IV. WHEREAS, THE ABOVE BOUNDEN _____ BEING DULY REGISTERED BY THE MOTOR
TRANSPORTATION DIVISION FOR CHARGING OF FEES SET FORTH IN STATUTES OF NEW MEXICO 66-3-320, 66-7-413, 65-2-19,
65-1-13, 65-1-14, 66-6-28, 7-16-4.2, 7-16-7, AND ALL FEES, PENALTY AND INTEREST ON FEES COLLECTED BY THE MOTOR
TRANSPORTATION DIVISION.

V. NOW THEREFORE, IF THE SAID _____ AS SUCH USER/DEALER SHALL PROMPTLY FILE TRUE
REPORTS AND MAKE PROMPT PAYMENT OF ANY AND ALL MOTOR VEHICLE FUEL FEES AND TAXES WHICH ARE NOW OR WHICH HEREAFTER
MAY BE LEVIED OR IMPOSED BY THIS STATE, TOGETHER WITH ANY AND ALL PENALTIES AND/OR INTEREST THEREON, AND SHALL IN
GENERAL FAITHFULLY COMPLY WITH THE PROVISIONS OF SAID CHAPTER 7, LAWS OF 1978 AND CHAPTER 66, LAWS OF 1978 AND
ALL AMENDMENTS THEREOF, THEN THIS OBLIGATION SHALL BE NULL AND VOID, OTHERWISE TO REMAIN IN FULL FORCE AND
EFFECT, PROVIDED HOWEVER THAT THE SURETY MAY BE RELEASED AND DISCHARGED FROM ANY AND ALL LIABILITY TO THE STATE
OF NEW MEXICO ACCRUING ON THIS OBLIGATION AFTER THE EXPIRATION OF NINETY (90) DAYS FROM THE DATE UPON WHICH SUCH
