WHEREAS, the said \_\_\_\_\_ has applied to the Insurance commissioner of the Commonwealth of Pennsylvania for a license to act as a Surplus Lines Agent, in accordance with Section 1601 et. seq. of the Act of May 17, 1921, P. L. 682, No. 284, as amended, and is required to give a bond unto the Commonwealth of Pennsylvania in the sum of not less than Fifty Thousand (\$50,000) Dollars, prior to the issuance of such license, such bond must be maintained concurrent with the term of the license.

NOW THE CONDITION OF THIS OBLIGATION IS SUCH, that is the above bounden \_\_\_\_\_ shall comply with all of the requirements of Section 1621 of the Act of May 17, 1921, P. L. 682, No. 284, as amended, then this obligation is to be void, but otherwise to remain in full force and effect.

The aggregate liability of the said surety for any and all claims on this bond shall not exceed the sum of Fifty Thousand (\$50,000) Dollars.

And further, the above principal and surety do hereby empower an Attorney of the Court of Record of the Commonwealth of Pennsylvania to appear for them, or either of them, and to confess a judgment or judgments in favor of the Commonwealth of Pennsylvania for the principal amount of this bond with cost of suit, waiving stay of execution, inquisition and all exemption laws.
